This practice test is suitable to help you prepare for a number of our tests & exercises, including the Trainability for Safety Test (TRFS) that you may be asked to sit in an assessment centre.

You need to give yourself 3 minutes to study and learn the 'Rules and Regulations for Shop Consultants' for a travel company below. Make any notes on rough paper.

Rules & Regulations for Shop Consultants

Shop consultants can only take ticket bookings in the shop between the hours of 08:00 - 17:30 Monday to Thursday and between 09:00 - 16:00 on Saturdays. At all other times customers can make credit card bookings directly using the travel transport website which is www.travel-transports.co.uk. The website is accessible 24 hours a day.

Airline tickets must be booked at least 3 days in advance of travel and payment by credit card must be made in full at least 2 days in advance of travel. Rail tickets can be booked and paid for on the day of travel. Discounted train fares only apply on tickets booked at least 5 days in advance of travel and payment can only be made using cash or cheque. Cruise tickets must be booked and paid for at least 10 days in advance of travel.

Once you have given yourself 3 minutes to learn the rules and regulations you are then ready to answer the questions. Put away your notes and turn this page upside down. Then answer the 5 questions on the next page from memory. Give yourself 5 minutes to answer the questions.
